



UMPIRES AGREEMENT 2022-2023

The following is an agreement between the NMCA, the Umpires and the Umpires' Association.

1. Membership:

The NMCUA is a full member of the NMCA, and an NMCUA representative will be invited to NMCA general meetings.

The UMG will comprise 1 Board Nominee (usually the GM), the UM and 1 nomination from the NMCUA.

All umpires will need to purchase the appropriate uniform from the NMCA. The yearly subscription fee will vary depending on the uniform requirements for the season. The NMCA will subsidise a portion of any new Umpires initial uniform cost.

2. Communication:

All communication regarding NMCUA issues will be by email between the UMG and the NMCUA Secretary. All correspondence must be acknowledged within 7 days of receipt.

3. Website:

The NMCUA are welcome to utilize the NMCA website (and other social media formats) for social notes, meetings times, etc.

4. Recruitment, Training, Assessment and Selection:

The UMG will have full responsibility of recruitment, training, assessment and selection. At times, the UMG may use an external body to assist in these areas. The policy for recruitment, training, assessment and selection will be set by the NMCA Board and adhered to by the UMG.

5. Umpires Match Reports:

The UM is to ensure on-line Umpires Match Reports (pitch conditions, votes, etc.) are entered on the NMCA preferred computer system.

6. Reporting Procedure:

Umpire(s) are to act on misconduct by players in accordance with Law 41.18 and Association Policy.

Umpire(s) are to advise Captains of a report, where practical.

Umpire(s) are to ensure correct notation of events and provide written reports, online reports and/or phone contact to the MRP in accordance with Association rules.

Umpire(s) will be generally available for hearings and appeals.

UMG will appoint an Umpires Advocate as required, for hearings and appeals.

7. Training & Development:

Umpires (full and part time) are to attend Training & Development meetings at venues and times stipulated by the UMG. Burland House will be available if required.

9. Adverse Weather:

Scenario	Fee
Play Abandoned by NMCA	No Fee
Attend game but no play (called before tea)	50% fee
Any play or stay past tea	Full fee

Umpires are required to remain at the ground unless they abandon days play under Law 9d, or both captains agree to abandon play under NMCA rules.

10. Senior Finals (Semi & Preliminary):

- An additional \$10.00 per day for all grades.
- Umpires to be paid on day 1 of match for both days.


11. Senior Grand Finals:

- An additional \$20.00 per day for all grades. Both days paid on day 1.
- Match Referee to be appointed to assist umpires in Grand Finals in the Jika, Quick and Kelly Shields.
- Match Referees to be appointed by the UMG at a fee of \$100.00 per match day, paid by the NMCA.
